- an fhoireann agus na daltai go leir a chur ar an eolas faoi shlainteachas riachtanach mar aon le beasaiocht anala agus riachtanais scaradh s6isialta
- an scoil a athch6iriu chun scaradh s6isialta a chur i bhfeidhm mar is oiriúnach le treoracha agus ordúithe na Roinne Oideachais
- logleabhar teaghmala a choimead chun chabhru le rianu teaghmala
- cinntiu go rachaidh an fhoireann i dteagmhail leis an bhfaisneis ionduchtaithe / taithiocha a chuir an Roinn Oideachais ar fail
- an pr6iseas comhaontaithe i gcás go mbeadh duine sa scoil ag taispeaint na gcomharthaf de COVID-19 agus iad ar scoil a chur i bhfeidhm
- treoracha a chur ar fail don fhoireann agus do na daltai i gcás go bhfuil siad ag taispeaint na gcomharthai de COVID-19 agus iad ar scoil
- glant6ireacht a chloionn le treoracha na Roinne Oideachais a dheanamh

Rachfar i comhairliuchan leis an bhfoireann ar bhonn leantach agus failtitear roimh aiseolas ar abhar imni ar bith, fadhbanna n6 moltaí.

Gaelscoil Dara COVID-19 Policy Statement

Gaelscoil Dara is committed to providing a safe and healthy workplace for all our staff and a safe learning environment for all our pupils. To ensure that, we have developed the following COVID-19 Response Plan. The BOM and all school staff are responsible for the implementation of this plan and a combined effort will help contain the spread of the virus. We will:

- continue to monitor our COVID-19 response and amend this plan in consultation with our staff
- provide up to date information to our staff and pupils on the Public Health advice issued by the HSE and Gov.ie
- display information on the signs and symptoms of COVID-19 and correct hand-washing techniques
- agree with staff, a worker representative who is easily identifiable to carry out the role outlined in this plan
- inform all staff and pupils of essential hygiene and respiratory etiquette and physical distancing requirements
- adapt the school to facilitate physical distancing as appropriate in line with the guidance and direction of the Department of Education
- keep a contact log to help with contact tracing
- ensure staff engage with the induction / familiarisation briefing provided by the Department of Education
- implement the agreed procedures to be followed in the event of someone showing symptoms of COVID-19 while at school
- provide instructions for staff and pupils to follow if they develop signs and symptoms of COVID-19 during school time
- implement cleaning in line with Department of Education advice

All school staff will be consulted on an ongoing basis and feedback is encouraged on any concerns, issues or suggestions.

This can be done through the Lead Worker Representative(s), who will be supported in line with the agreement between the Department and education partners.
