WHAT PERSONAL DATA DO WE COLLECT FROM YOU AND HOW DO WE USE IT?

The collection of personal data is an essential to running a school and providing care and education for your children and we therefore have specific measures and controls in place to ensure that we comply with the conditions outlined in the data protection laws.

Gaelscoil Dara must have a lawful basis to collect and use personal information. These legal bases are explained below:

CONSENT AND HOW TO WITHDRAW CONSENT

If we process your personal data based on consent, you have the right to withdraw that consent at any time.

HOW AND WHERE DO WE GET YOUR PERSONAL INFORMATION FROM?

We get your personal data directly from you when you complete our enrolment forms, other school forms (e.g. Permission slips), email us or phone us.

We do not record the audio of telephone calls, but may have a log on when you called, call length, to whom you spoke, and what the subject of that call was.

WHO MAY ACCESS YOUR PERSONAL DATA?

As set out above, Gaelscoil Dara is committed to respecting the privacy of your personal data, and to processing such data in accordance with the data protection laws. It is important to know we do not sell your personal data.

YOUR PERSONAL DATA MAY ALSO BE PROCESSED BY POD AND ALADDIN AND THE DEPT. OF EDUCATION AND SKILLS

We interact with trusted third parties to record attendance, and other pertinent information concerning your child's education and trends within the Education system.

WE MAY ALSO DISCLOSE YOUR PERSONAL DATA TO THIRD PARTIES

Gaelscoil Dara may disclose information when legally compelled to do so; in other words, when, in good faith, it is believed that the law requires it or for the protection of the Gaelscoil Dara's legal rights. In other circumstances we may disclose if we have your consent or we are permitted to do so by law.

HOW LONG DO WE KEEP YOUR PERSONAL DATA?

This will vary dependent on the nature of the data. These include:

- The purpose for which we hold your personal data;
- Our legal and regulatory obligations in relation to that personal data; and
- Any specific requests from you in relation to the deletion of your personal data. When

we no longer need to retain your personal data, it will be destroyed to best standards.

IS YOUR DATA SECURE?

Gaelscoil Dara takes data privacy seriously. We are committed to keeping your personal data secure and taking all reasonable precautions to do so. We deploy appropriate organisational measures to keep personal information secure.

We always do our best to protect your personal data and once we have received your personal data, we use strict procedures and security to try to prevent unauthorised access.

Unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure. As a result, while Gaelscoil Dara strives to protect all Users' personal information, Gaelscoil Dara cannot ensure or warrant the security of any information transmitted to Gaelscoil Dara via the Internet.

- The right to data portability by receiving your personal data in a structured, commonly used format:
- The right to lodge a complaint with a supervisory authority.
